**Permit Issuance**

For the issuance of each mechanical permit:

Commercial	<b>\$30.00</b>
Residential	<b>\$15.00</b>
For issuing each supplemental permit for which the original permit has not expired, been canceled or finalized	<b>\$8.00</b>

**Unit Fee Schedule**

Please note that the following do not include the permit issuance fee.

***Furnaces:***

For the installation or relocation of each forced-air or gravity-type furnace or burner, including ducts and vents attached to such appliance, up to and including 100,000 Btu/h (29.3kW)	<b>\$17.05</b>
For the installation or relocation of each forced-air or gravity-type furnace or burner, including ducts and vents attached to such appliance over 100,000 Btu/h (29.3kW)	<b>\$21.01</b>
For the installation or relocation of each floor furnace, including vent or heat pump	<b>\$17.05</b>
For the installation or relocation of each suspended heater, recessed wall heater or floor-mounted unit heater	<b>\$17.05</b>

***Appliance Vents:***

For the installation, relocation or replacement of each appliance vent installed and not included in an appliance permit	<b>\$8.35</b>

***Repairs or Additions:***

For the repair of, alteration of, or addition to each heating appliance, refrigeration unit, cooling unit, absorption or each heating, cooling, absorption or evaporative cooling system, including installation of controls regulated by the Mechanical Code	<b>\$15.85</b>

***Ventilation and Exhaust:***

For each ventilation fan connected to a single duct	<b>\$8.35</b>
For each ventilation system which is not a portion of any heating or air-conditioning system authorized by a permit	<b>\$12.30</b>
For the installation of each hood which is served by mechanical exhaust, including the ducts for such hood	<b>\$12.30</b>

**Boilers, Compressors and Absorption Systems (AC Units):**

For the installation or relocation of each boiler or compressor up to and including 3 horsepower (10.6 kW) or each absorption system up to and including 100,000 Btu/h (29.3kW)	<b>\$16.95</b>
For the installation or relocation of each boiler or compressor over 3 horsepower (10.6 kW) up to and including 15 horsepower (52.7kW), or each absorption system up to and including 500,000 Btu/h (146.6kW)	<b>\$31.35</b>
For the installation or relocation of each boiler or compressor over 15 horsepower (52.7 kW) up to and including 30 horsepower (105.5kW), or each absorption system over 500,000 Btu/h (29.3kW) up to and including 1,000,000 Btu/h (293.1kW)	<b>\$43.00</b>
For the installation or relocation of each boiler or compressor over 30 horsepower (105.5 kW) up to and including 50 horsepower (176kW), or each absorption system over 1,000,000 Btu/h (293.1kW) up to and including 1,750,000 Btu/h (512.9kW)	<b>\$64.00</b>
Each absorption system over 1,750,000 Btu/h (512.9kW)	<b>\$107.00</b>

**Evaporative Coolers**

For each evaporative cooler other than portable type	<b>\$12.30</b>

**Air Handlers\*:**

For each air-handling unit up to and including 10,000 cubic feet per minute (cfm) (4,179 L/s), including ducts attached thereto	<b>\$12.30</b>
For each air-handling unit over 10,000 cfm (4719 L/s)	<b>\$20.90</b>

\*Please note that this fee does not apply to an air-handling unit which is a portion of a factory-assembled appliance, cooling unit, evaporative cooler, or absorption unit for which a permit is required elsewhere in the Mechanical Code.

**Incinerators:**

For the installation or relocation of each domestic type incinerator	<b>\$20.90</b>
For the installation or relocation of each commercial or industrial type incinerator	<b>\$16.70</b>

**Miscellaneous:**

For each appliance or piece of equipment regulated by the Mechanical Code but not classed in other appliance categories, or for which no other fee is listed in the Master Fee Ordinance	<b>\$12.30</b>

**Other Inspections and Fees:**

Inspections outside of normal business hours (min. charge – 2 hr)	<b>\$45.00/hr*</b>
Re-inspection fees assessed under provisions of Section 116.6	<b>\$45.00/insp.*</b>
Inspections for which no fee is specifically indicated (min. charge – ½ hr)	<b>\$45.00/hr*</b>
Additional plan review required by changes, additions or revisions to plans or to plans for which an initial review has been completed (min. charge – ½ hr)	<b>\$45.00/hr*</b>

\*Or the total hour cost to the jurisdiction, whichever is greatest. This cost shall include supervision, overhead, equipment, hourly wages, and fringe benefits of the employees involved.
