RETENTION OF SERVIICES – GARY JORN – MAYOR SHAWNA BINDLE



THERE BEING NO FURTHER BUSINESS, THE MEETING WAS ADJOURNED AT 5:08 P.M.


I, the undersigned, City Clerk for the City of Falls City, Nebraska, hereby certify that the foregoing is a true and
