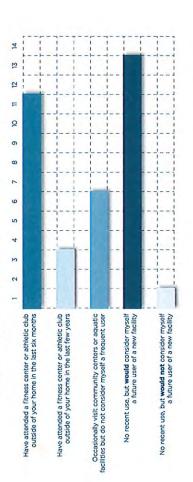

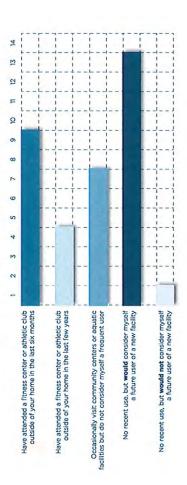

PUBLIC + STAKEHOLDER MEETINGS

Eight stakeholder and community engagement meetings were held on August 29th and 31st at the Southeast Community College Learning Center in Falls City. Four meetings were focused on key groups, with representatives from the schools; the hospital; early education experts and advocates; local economic development professionals; and the Rotary Club, amongst others. The remaining four meetings were open to all members of the public. Over 40 community members participated.

The purpose of the meetings was to gauge general interest in a recreational facilities, as well as to identify specific uses, services, and amenities that the community would like to see in a potential future recomment.

Aggregated responses to the surveys conducted within the stakeholder and community meetings are shown to the left and on the following page.

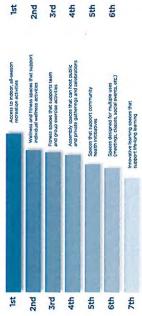
In addition to the survey results, a few key items were repeatedly discussed, including:

- A strong interest in the inclusion of an enclosed pool. This was noted
  in almost every meeting, with a keen interest in a pool's potential use
  by seniors and those requiring physical rehabilitation. Children's parties
  were also noted, along with general uses.
- The need within Falls City for a place for middle-school kids to hang out after the school day, Precedents of technology rooms and open gyms were discussed as good draws for that group.
- Concerns with facility staffing any recreation center should be designed to minimize staffing and maintenance requirements, while still prioritzing security. Lifeguards were specifically identified, as it was noted that there is current difficulty staffing the public pool, particularly at the end of the season.
- Need to further understanding the cost to use the facility as well as
  how it will be funded. There was interest in making sure that the facility
  is welcoming with facilities that are available to everyone balanced with
  fee-based uses to fund long-term operation.
- The need to think big. A new facility should focus on providing amenities that would not otherwise be possible and not compete with or displaced existing locally-owned small businesses, such as fitness centers.
- The potential facility should focus on multi-generational engagement.

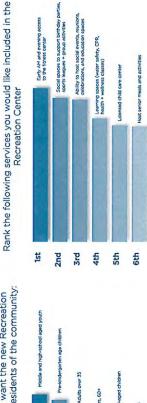

# SELECTED OPTIONS FOR EVALUATION

Based upon community feedback, understanding of priorities, and discussion of the potential to enhance existing facilities - including Prichard Auditorium and the Armory Building - the steering committee identified the following areas of focus:

- Evaluate and provide conceptual design analysis for the renovation of Prichard Auditorium into a full rec center, including the following spaces identified in the program sections: Admin, Fitness, Athletics, Therapy Water, and Community.
- Evaluate and provide conceptual design analysis for the renovation of the Armory Building into an event space, to supplement the loss of Prichard as the primary event venue.
- Provide diagrammatic site plan for a new standalone recreation center and aquatics facility located the Armory building site. This building would include spaces identified in the full program list: Admin, Fitness, Athletics, Aquatics and Community.

Each option provides both opportunities and challenges. Some benefits/opportunities include:

- Prichard Auditorium and the Armory Building are currently underused community resources and can be renovated to provide better, daily services to Falls City and potentially reduce initial capital costs.
- Construction of a new stand-alone facility creates an opportunity to meet the community's program aspirations without the limitations of an existing building.

Challenges include:

- Adapting to the constraints of existing buildings may limit some design efficiency or desires.
- Staffing and securing two facilities rather than one may add operational costs and duplicate some spaces.

Some sub-contractors are only holding their bids for 5-15 days in lieu of 90+ days. It is typically assumed material costs are updated annually, but at this time they are rising weekly and monthly. As to the future, some reports have indicated this could last 6 months to a year. We are working hard to provide the most accurate unit costs in our estimates. In our 36 years of estimating, we have never experienced such volatility in material costs.

- Joined ESU4 administrators in Auburn on 10/20 to discuss the Perkins Grant program and how economic developers can assist schools with workforce development.
- Attended Bio Nebraska's Annual Meeting on 10/26 where they promote, connect, and catalyze the biosciences in Nebraska.
- Attended Falls City High's Career College Day on 11/1 to discuss local employment opportunities. A heavy emphasis was put on learning a trade. Presented a similar message to the seniors at Sacred Heart the following day.
- Working to outline parameters for a Community Childcare Fund. The goal is to increase childcare capacity for working parents.
- Discussions on how to best utilize Rural Workforce Housing Funds continue.
- The EDGE Annual Report will appear in the Falls City Journal this week.

# Professional Service Agreement Falls City & SENDD General Administration Contract for Downtown Revitalization Project 23DTR006

**THIS AGREEMENT** made and entered into by and between the **City** of <u>Falls City</u>, **Nebraska** (hereinafter referred to as the City) and Southeast Nebraska Development District, (hereinafter referred to as the Consultant).

#### WITNESSES THAT:

**WHEREAS,** the City, <u>2307 Barada St, Falls City, NE 68355</u> and the Consultant, 7407 O St, Lincoln, NE 68510 are desirous of entering into a contract to formalize their relationship, and

WHEREAS, pursuant to Title I of the Housing and Community Development Act of 1974, as amended through 1981 and 24 CFR 570, the State of Nebraska Department of Economic Development (the Department) is authorized by the federal Department of Housing and Urban Development (HUD) to provide Community Development Block Grant Program funds (hereinafter referred to as CDBG funds) to units of local government selected to undertake and carry out certain programs and projects under the Nebraska State Community Development Block Grant Program in compliance with all applicable local, state and federal laws, regulations and policies, and

WHEREAS, the City, as part of its 2023 CDBG grant agreement withthe Department, under contract number 23DTR006 , has been awarded CDBG funds for the purposes set forth herein, and

**WHEREAS,** the Scope of Work included in this contract is authorized as part of the City 's approved CDBG program, and

**WHEREAS**, it would be beneficial to the City to utilize the Consultant as an independent entity to accomplish the Scope of Work set forth herein and such endeavor would tend to best accomplish the objectives of the local CDBG program.

**NOW, THEREFORE,** in consideration of the mutual promises, covenants and provisions contained herein and the mutual benefits to be derived the refrom, the parties here to agree as follows:

# 1. Services to be Provided by the Parties

- **a.** The Consultant shall complete, in a satisfactory and proper manner as determined by the City, the work activities described in the Scope of Work (**Attachment #1**).
- **b.** The City will provide such assistance and guidance as may be required to support the objectives set forth in the Scope of Work and will provide compensation for services as set forth in Section 3 Compensation below.

#### 2. Time of Performance

The start of the contract shall be <u>November 16, 2023</u>. The termination date of the contract shall be <u>May 15, 2026</u>. The effective date of this contract shall be the date the parties sign and complete execution of the contract.

# 3. Compensation

The City shall reimburse the Consultant in accordance with the Implementation projected Budget described in **Attachment #2** for all allowable expenses agreed upon by the parties to complete the Scope of Work. Contract will not use cost-plus or percentage of cost basis. In no event shall the total amount reimbursed by the City exceed the sum of \$25,000 \_\_\_\_. Reimbursement under this contract shall be based on billings that are supported by appropriate documentation of costs actually incurred. It is expressly understood that claims for reimbursement shall not be submitted in excess of actual, immediate cash requirements necessary to carry out the purposes of this agreement.

It is also understood that this contract is funded in whole or in part with funds through the State of Nebraska Community Development Block Grant Program as administered by the Department and is subject to those regulations and restrictions normally associated with federally funded programs.

# 4. Record Maintenance, Record Retention, and Access to Records

The Consultant agrees to maintain such records and follow such procedures as may be required under 2 CFR §200.300–345 and any such procedures that the City or the Department may prescribe. In general, such records will include information pertaining to the contract, obligations and unobligated balances, assets and liabilities, outlays, equal opportunity, labor standards (as appropriate), and performance.

All such records and all other records pertinent to this contract and work undertaken under this contract shall be retained by the Consultant for a period of ten years after the final audit of the City's CDBG project unless a longer period is required to resolve audit findings or litigation. In such cases, the City shall request a longer period for record retention.

The City, the Department, and duly authorized officials of the state and federal government shall have full access and the right to examine any pertinent documents, papers, records and books of the Consultant involving transactions to this local program and contract.

# 5. Relationship

The relationship of the Consultant to the City shall be that of an independent Consultant rendering professional services. The Consultant shall have no authority to execute contracts or to make commitments on behalf of the City and nothing contained herein shall be deemed to create the relationship of employer and employee or principal and agent between the City and the Consultant.

# 6. Suspension, Termination and Close Out

If the Consultant fails to comply with the terms and conditions of this contract the City may pursue such remedies as are legally available including, but not limited to the suspension or termination of this contract in the manner specified herein:

a. Suspension: If the Consultant fails to comply with the terms and conditions of this contract, or whenever the Consultant is unable to substantiate full compliance with the provisions of this contract, the City may suspend the contract pending corrective actions or investigation, effective not less than 7 days following written notification to the Consultant or its authorized representative. The suspension will remain in full force and effect until the Consultant has

taken corrective action to the satisfaction of the City and is able to substantiate its full compliance with the terms and conditions of this contract. No obligations incurred by the Consultant or its authorized representatives during the period of suspension will be allowable under the contract except:

- i. Reasonable, proper and otherwise allowable costs which the Consultant could not avoid during the period of suspension.
- ii. If upon investigation, the Consultant is able to substantiate complete compliance with the terms and conditions of this contract, otherwise allowable costs incurred during the period of suspension will be allowed.
- iii. In the event all or any portion of the work prepared or partially prepared by the Consultant be suspended, abandoned, or otherwise terminated the City shall pay the Consultant for work performed to the satisfaction of the City, in accordance with the percentage of the work completed.
- b. Termination for Cause: The City may terminate its contract with the Consultant if the Consultant fails to comply with the terms and conditions of this contract and any of the following conditions exist.
  - i. The lack of compliance with the provisions of this contract are of such scope and nature that the City deems continuation of the contract to be substantially detrimental to the interests of the City;
  - **ii.** The Consultant has failed to take satisfactory action as directed by the City or its authorized representative within the time specified by same;
  - iii. The Consultant has failed within the time specified by the City or its authorized representative to satisfactorily substantiate its compliance with the terms and conditions of this contract; then, the City may terminate this contract in whole or in part, and thereupon shall notify the Consultant of the termination, the reasons therefore, and the effective date provided such effective date shall not be prior to notification of the Consultant. After this effective date, no charges incurred under any terminated portions are allowable.
- c. Termination for Other Grounds: This contract may also be terminated in whole or in part:
  - i. By the City, with the consent of the Consultant, or by the Consultant with the consent of the City, in which case the two parties shall devise by mutual agreement, the conditions of termination including effective date and in case of termination in part, that portion to be terminated.
  - **ii.** If the funds allocated by the City via this contract are from anticipated sources of revenue, and if the anticipated sources of revenue do not become available for use in purchasing said services.

- iii. In the event the City fails to pay the Consultant promptly or within 60 days after invoices are rendered, the City agrees that the Consultant shall have the right to consider said default a breach of this agreement and the duties of the Consultant under this agreement terminated. In such an event, the City shall then promptly pay the Consultant for all services performed and all allowable expenses incurred.
- iv. The City may terminate this contract at any time giving at least 10-days' notice in writing to the Consultant. If the contract is terminated for convenience of the City as providedherein, the Consultant will be paid for time provided and expenses incurred upto the termination date.

# 7. Changes, Amendments, Modifications

The City may, from time to time, require changes or modifications in the scope of services to be performed hereunder. Such changes, including any increase or decrease in the amount of compensation therefore, which are mutually agreed upon by the City and the Consultant shall be incorporated in written amendments to this contract.

#### 8. Personnel

The Consultant represents that he/she has, or will secure at his/her own expense, all personnel required in performing the services under this contract. Such personnel shall not be employees or have any contractual relationship to the City.

All services required hereunder will be performed by the Consultant or under his supervision and all personnel engaged in the work shall be fully qualified and shall be authorized or permitted under state or local law to perform such services.

None of the work or services covered by this contract shall be subcontracted without prior written approval of the City. Any work or services subcontracted hereunder shall be specified by written contract or agreement and shall be subject to each provision of this contract.

#### 9. Assignability

The Consultant shall not assign any interest on this contract and shall nottransfer any interest on this contract (whether by assignment or notation), without prior written consent of the City thereto: Provided, however, that claims for money by the Consultant from the City under this contract may be assigned to a bank, trust company, or other financial institutions without such approval. Written notice of any such assignment or transfer shall be furnished promptly to the City.

# 10. Reports and Information

The Consultant, at such times and in such forms as the City may require, shall furnish the City such periodic reports as it may request pertaining to the work or services undertaken pursuant to this contract, the costs and obligations incurred or to be incurred in connection therewith, and any other matters covered by this contract.

#### 11. Findings Confidential

All of the reports, information, data, etc., prepared or assembled by the Consultant under this contract are confidential and the Consultant agrees that they shall not be made available to any

individual or organization without prior written approval of the City.

## 12. Copyright

No reports, maps, or other documents produced in whole or in part under this contract shall be subject of an application for copyright by or on behalf of the Consultant.

## 13. Compliance With Local Laws

The Consultant shall comply with all applicable laws, ordinances and codes of the state and local governments and the Consultant shall save the City harmless with respect to any damages arising from any tort done in performing any of the work embraced by this contract.

## 14. Title VI of the Civil Rights Act of 1964

No person shall, on the grounds of race, color or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

## 15. Section 109 of the Housing and Community Development Act of 1974

No person in the United States shall on the grounds of race, color, national origin, or sex be excluded from participation in, be denied benefits of or be subjected to discrimination under any program or activity funded in whole or in part with funds made available under this title.

## 16. Build America, Buy America Act (BABA).

The City must comply with the requirements of the Build America, Buy America (BABA) Act, 41 USC 8301 note, and all applicable rules and notices, as may be amended, if applicable to the City's infrastructure project. Pursuant to HUD's Notice, "Public Interest Phased Implementation Waiver for FY 2022 and 2023 of Build America, Buy America Provisions as Applied to Recipients of HUD Federal Financial Assistance" (88 FR 17001), any funds obligated by HUD on or after the applicable listed effective dates, are subject to BABA requirements, unless excepted by a waiver.

The City shall include this BABA clause in any procurement bid/contract documents to ensure BABA compliance by subgrantees, developers and/or contractors.

## 17. Section 3 Compliance in the Provision of Training, Employment and Business Opportunities

- a. The work to be performed under this contract is on a project assisted under a program providing direct federal financial assistance from the Department of Housing and Urban Development and is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u. Section 3 requires that to the greatest extent feasible opportunities for training and employment arising in connection with Section 3 projects are provided to Section 3 workers (as defined in 24 CFR Part 75) within the metropolitan area (or nonmetropolitan county) in which the project is located and contracts for work awarded in connection with Section 3 projects are provided to business concerns that provide economic opportunities to Section 3 workers residing in the metropolitan area (or nonmetropolitan county) in which the project is located.
- **b.** The parties to this contract will comply with the provisions of said Section 3. The parties to this contract certify and agree that they are under no contractual or other disability which would

prevent them from complying with these provisions.

- c. The Consultant will send to each labor organization or representative or workers with which he/she has collective bargaining agreement or other contract or understanding, if any, a notice advising the said labor organization or workers' representative of his/her commitments under this Section 3 clause and shall post copies of the notice in conspicuous places available to employees and applicants for employment or training.
- d. The Consultant will include this Section 3 clause in every subcontract for work in connection with the project and will, at the direction of the applicant for, or receipt of federal financial assistance, take appropriate action pursuant to the subcontract upon a finding that the subcontractor is in violation of regulations issued by the Secretary of Housing and Urban Development, 24 CFR Part 75. The Consultant will not subcontract with any subcontractor where it has notice or knowledge that the latter has been found in violation of regulations under 24 CFR Part 75 and will not let any subcontract unless the subcontractor has first provided it with a preliminary statement of ability to comply with the requirements of these regulations.
- e. Compliance with the provisions of Section 3, the regulations set forth in 24 CFR Part 75, and all applicable rules and orders of the Department issued hereunder prior to the execution of the contract, shall be a condition of the federal financial assistance provided to the project, binding upon the applicant or recipient for such assistance, its successors and assigns. Failure to fulfill these requirements shall subject the applicant or recipient, its consultants and subcontractors, its successors and assigns to those sanctions specified by the grant or loan agreement or contract through which federal assistance is provided, and to such sanctions as are specified by 24 CFR Part 75.

## 18. Age Discrimination Act of 1975, As Amended (42 U.S.C. 6101 et. seq.)

No person will be excluded from participation, denied program benefits or subjected to discrimination on the basis of age under any program or activity receiving federal funding assistance.

## 19. Section 504 of the Rehabilitation Act of 1973, As Amended (29 U.S.C. 794)

No otherwise qualified individual will, solely by reason of his or her handicap, be excluded from participation (including employment), denied program benefits or subjected to discrimination under any program or activity receiving federal assistance funds.

## 20. Executive Order 11246. As Amended

This Order applies to all federally assisted construction contracts/subcontracts (that exceed \$10,000) and non-construction/service contracts and subcontracts (that exceed \$50,000). The Subrecipient and subcontractors, if any, will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The Grantee and subcontractors, if any, will take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin.

## 21. Conflict of Interest 2 CFR §200.318

No officer, employee or agent of the Grantee who will participate in the selection, the award, or

the administration of this grant may obtain a personal or financial interest or benefit from the activity or have an interest in any contract, subcontract or agreement with respect thereto, or the proceeds thereunder either for themselves or those with whom they have family or business ties, during their tenure or for one year thereafter. It is further required that this stipulation be included in all subcontracts to this contract. Upon written request, exceptions may be granted upon a case-by-case basis when it is determined that such an exception will serve to further the purposes of the Act and the effective and efficient administration of the recipient's program or project. These exceptions are granted by the Department.

## 22. Audits and Inspections

The City, the Department, the State Auditor and HUD or their delegates shall have the right to review and monitor the financial and other components of the work and services provided and undertaken as part of the CDBG project and this contract, by whatever legal and reasonable means are deemed expedient by the City, DED, the State Auditor and HUD.

## 23. Hold Harmless

The Consultant agrees to indemnify and hold harmless the City, its appointed and elected officers and employees, from and against all loss and expense, including attorney's fees and costs by reason of any and all claims and demands upon the City, its elected or appointed officers and employees from damages sustained by any person or persons, arising out of or in consequence of the Consultant's and its agents' negligent performance of work associated with this agreement. The Consultant shall not be liable for property and bodily injury as may result from the negligence of any construction contractor or construction subcontractor.

## 24. Governing Law

This Agreement will be governed by the laws of the State of Nebraska, without regard to that body of law controlling conflicts of law. Any legal proceeding arising out of, or relating to this Agreement, shall be instituted in any court of general jurisdiction in the State of Nebraska.

## EMERGENCY & NON-EMERGENCY DISPATCH SERVICES INTERLOCAL AGREEMENT

THIS AGREEMENT is made and entered into on this	2024 by and between the City
of Falls City, Nebraska, a Municipal Corporation, hereinafter referred to	
Richardson, Nebraska, a body politic and corporate, hereinafter referred to	

## WITNESSETH:

WHEREAS, Neb. Rev. Stat. Section 18-1707 authorizes City to contract with County for services provided by City of a type which City is empowered to perform; and Neb. Rev. Stat. Section 86-440 authorizes a governing body as provided by law to contract with any political subdivision for the administration of 911 services; and

WHEREAS, an Interlocal Cooperation Act Agreement pursuant to Neb. Rev. Stat. Section 13-801 et. seq. is in the best interest of City and County; and

WHEREAS, City operates and maintains a Public Safety Answering Point (PSAP) including an Enhanced 911 System within Richardson County for the telephone exchanges; and

WHEREAS, the City and Richardson County desire to maintain a PSAP within Richardson County for the mutual benefit of each entity and their responsibility to the citizens residing in Richardson County; and

WHEREAS, County desires to contract with City for the operation of an Enhanced 911 System for telephone exchanges within the jurisdiction of Richardson County, Nebraska, including any relevant interlocal agreements; and

WHEREAS, County desires to contract with City for the operation of non-emergency dispatching telephone exchanges within the jurisdiction of Richardson County, Nebraska, including any relevant interlocal agreements; and

WHEREAS, in addition to the dispatching services, City and County desire to enter into an agreement wherein City shall provide information technology (IT) services related to the Computer Aided Dispatch ("CAD") systems as utilized by County.

WHEREAS, in addition to the dispatching services, City and County desire to enter into an agreement wherein City shall provide access to mobile deployment software as utilized by County.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

1. Term. The term of this Agreement shall begin on August 1, 2024. This Agreement shall automatically renew annually, hereinafter, unless either party gives notice of termination as set forth in this Agreement.

2. Enhanced 911 System, Radio Dispatch System, and Computer Aided Dispatch (CAD). The City agrees to operate and maintain primary Enhanced 911 and radio dispatch systems, including Computer Aided Dispatch ("CAD") systems, at 2307 Barada Street, Falls City, Nebraska ("Falls City 911 Center"). City agrees to utilize these systems to monitor, record, document, and receive emergency and non-emergency calls for service originating from Richardson County telephone exchanges. City agrees to dispatch appropriate personnel from the Richardson County Sheriff's Office, the Falls City Police Department, the Rural Volunteer Fire and Rescue Departments, the Falls City Fire and Rescue Departments, and/or emergency medical services that are located within Richardson County. City agrees to notify other agencies other than Richardson County emergency personnel (e.g., law enforcement, medical, fire, emergency management and other mutual aid services) as requested. City further agrees to maintain associated records and recordings.

Richardson County shall provide at its cost all necessary receiving radio towers and radio equipment for personnel and volunteers in the direct employ or under the direct supervision of County, including portable and mobile radios, mobile data computers and pager units, in order for County personnel to communicate with the Falls City 911 Center. It is understood by County that periodic upgrades of such equipment will be necessary in order for such equipment to be compatible with the systems within the Falls City 911 Center.

Each agency is to maintain an inventory list to be reviewed and updated annually. Any equipment additions or upgrades would initially be presented to the appropriate advisory committee for review and recommendation.

IT Duties. City agrees to perform the technical services necessary to ensure that the Falls City 911 Center functions fully and efficiently, including services related to CAD as utilized by Richardson County emergency responders. Furthermore, City agrees to perform said services with the standard of care and skill customarily provided in the industry for performance of such services.

- 3. Other Services. City shall also:
  - (a) Receive and process telephone calls transferred from County via administrative lines.
  - (b) Make the NCIC/NCIS service located at the Falls City 911 Center available to County law enforcement officials so long as the requirements for access to this service are complied with.
  - (c) Activate county paging, alerting of fire and rescue calls when dispatched.
  - (d) Inform County Sheriff's Office and/or Volunteer Fire and Rescue Department command officer(s) of significant incidents, pursuant to mutually agreed upon procedures.
  - (e) Conduct pager testing pursuant to mutually agreed upon procedures.
  - (f) Page members of the Richardson County Rural Volunteer Fire and Rescue Departments and ambulance.
  - (g) Provide County with available copies of audio recordings of radio and telephone communications upon request.

- (h) Provide routine information technology (IT) services for Falls City 911 Center system software and communication mediums between the Falls City 911 Center and County.
- **4. Richardson County Fee.** County agrees to pay the following amounts for services provided in this Agreement:
  - (a) County agrees to pay a one-time fee of Sixty-Three Thousand Nine Hundred Dollars (\$63,900.00) on or before August 1, 2024. This one-time fee will recover expenses incurred to hire and train two (2) additional dispatchers to be graduated from training by August 1, 2024. An additional two (2) dispatchers are needed to attain eight (8) full-time dispatchers for dual dispatching capabilities.
  - (b) County agrees to reimburse the City a total of fifty percent (50%) of the net expense of Falls City Fund 205 E911/Dispatching for the period beginning on August 1, 2024, to be paid in monthly installments. The City will invoice the County on a monthly basis detailing the County portion of the total revenue and expenses of Fund 205 for each corresponding month. Invoices are due within 30 days of issuance.
  - (c) County agrees to reimburse the City for County access to City's mobile deployment software proportionally to the use of the user licenses. The city will invoice the County as expenses are incurred. Invoices are due within 30 days of issuance.
- **5. No Joint Property.** City and County agree that there will be no property jointly owned between them to be disposed of at the termination of this agreement.
- 6. Procedures. Having direct managerial control of the Falls City 911 Center, the City Chief of Police shall establish policies and procedures for dispatch services and oversee personnel employed within the Falls City 911 Center, with consideration given to recommendations of the advisory committee.
- 7. Law Enforcement & Emergency Dispatching Advisory Committee. The parties hereby agree that an advisory committee shall be formed consisting of a representative of each law enforcement agency and representatives of all affected fire, rescue, and ambulance services served by the Falls City 911 Center. Each entity served by the Falls City 911 Center shall appoint one representative for the committee. This committee shall not constitute a separate governmental entity. The committee shall meet at least semi-annually and shall perform the following duties:
  - (a) Make recommendations concerning the operation of the Falls City 911 Center and its future development; and
  - (b) Make recommendations concerning maintenance and/or replacement of equipment and property for the aforementioned systems.
- 8. Liability. County shall save and hold harmless City from all losses, claims, and damages arising out of the negligent or intentional acts or omissions of County or its agents or employees in the performance of this Agreement. Likewise, City shall save and hold harmless County from all losses, claims, and damages arising out of the negligent or intentional acts or omissions of City or its agents or employees in the performance of this Agreement.

- 9. Termination. This agreement may be terminated by either City or County by giving the other party notice thereof at least one hundred and eighty (180) calendar days before the beginning of the next term. Such notice shall be in writing and shall reference a resolution duly passed by the respective governing body requesting such termination. This agreement may be amended at any time with the written authority of the local governing bodies of both City and County.
- **10. Amendment of Agreement**. This Agreement may only be amended by the consent of City and County. The amendment must be in writing and signed by both parties.
- 11. Governing Law. This Agreement shall be construed in accordance with and governed by the laws of the State of Nebraska.
- 12. Counterparts. This Agreement may be executed in two (2) or more counterparts, each of which shall be deemed an original but all of which together shall be and constitute one and the same instrument.
- 13. Severability. If one or more of the covenants or agreements provided in this Agreement shall be declared by any court of competent jurisdiction to be contrary to law, then such covenant or covenants, agreement or agreements, shall be null and void and shall be deemed separable from the remaining covenants and agreements, and shall in no way affect the validity of any other provisions of this Agreement.
- 14. Assignability, Successors, & Assigns. This Agreement shall not be assignable by City or County without express written consent from the other party. All the covenants and representations contained in this Agreement, by or on behalf of City or County, shall bind and inure to the benefit of each party's respective successors and assigns whether so expressed or not.
- 15. Article & Section Headings. The headings or titles of several paragraphs hereof shall be solely for the convenience of reference and shall not affect the meaning or construction, interpretation or effect of this Agreement.
- **16. Anti-Discrimination.** In connection with the performance of work under this Agreement, City and County agree that it shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, disability, national origin, age or marital status.
- 17. Entire Agreement. This Agreement contains the entire Agreement between the parties hereto, and no agreements or warranties, oral or written, shall be considered as binding on the parties unless set forth herein.

## Farris Engineering Reference Document: Scope of Work for Arc Flash Study

## GENERAL Outline:

- a. The purpose of this study is to provide a comprehensive software model of Falls City Power Plant Building, Generation and Feeders Circuits to first termination point on the Distribution system. This will document compliance with NFPA 70E mandates, as described below. This will serve as an integral part of an ongoing safety program by providing arc flash calculations in compliance with NFPA-70E 2004 Article 130.1(A)(2).
  - 1. Article 205.3, 120.2(F)(1): Updated and verified one-line diagram for Falls City Power Plant Building.
  - Article 400.5, 400.6: Updated short circuit and equipment duty verification study showing all electrical equipment is properly rated to withstand and interrupt the available short circuit duty per ANSI Standards and NEMA/UL/NEC requirements.
  - 3. Article 130.3(A)(B), 110.8: Updated arc flash study providing maximum incident energies, arc flash boundaries, and PPE requirements for equipment in the Power Plant Building.
  - 4. Article 130.16(E), 400.11, 400.14, 400.21(C)(2), 410.8: Updated labeling displaying the worst-case arc hazard values for equipment in the Power Plant Building.
- b. The analysis shall consist of the following:
  - 1. Field data collection by qualified personnel.
  - Data entry and system one-line modeling in commercially available power system software.
  - Model verification
  - 4. Short Circuit and equipment verification study.
  - Protective device coordination study.
  - Arc flash hazard study.
  - Detailed report and findings of the analysis.
  - 8. Electronic copies of the Project Report and the System Modeling Files.
  - 9. Review of a draft copy of the report and presentation of the final copy of the report.
  - Hard copies of the project report shall be included in proposed project pricing.
- c. The analysis and procedures shall comply with the following standards and recommended practices for power system studies.
  - 1. NFPA-70E, 2004 Standard for Electrical Safety in the Workplace
  - 2. IEEE-1584-2002

- 3. IEEE-242 "Buff Book" Protection and Coordination of Industrial Power Systems
- 4. IEEE-399 "Brown Book" Power System Analysis
- 5. IEEE-141 "Red Book" Electric Power Distribution for Industrial Plants

## II. DATA COLLECTION

- 1. Field data collection shall be performed by a qualified consultant to ensure accurate equipment modeling.
- The consultant shall review all the safety requirements and shall comply with all requirements.
- 3. Equipment shall be visually inspected to collect the necessary nameplate data used in the analysis. Consultant is responsible for visual verification of this data, including transformers, switchgear and breakers, relays, direct-acting trip units, etc. Data that may not be readily accessible or may not have nameplate data such as conductors, busway, etc. will be provided by the Falls City.
- The Falls City shall provide qualified personnel to show consultant equipment location and to open all equipment doors, locks, etc. necessary to collect nameplate data.

## III. SYSTEM MODELING

- The system model shall be developed using a commercially available, fully integrated software package that meets the performance specifications to ensure compliance with NFPA-70E 2004, ANSI, and IEEE Standards, and OSHA mandates.
- System model shall be laid out in one drawing/view and in a manner that provides
  for easy viewing of all analysis results. The one drawing/view requirement ensures
  that problem areas found and highlighted by the program are easily seen and not
  hidden or buried in multiple drawings, eliminating potential human errors where
  multiple drawing verification is required.
- 3. All one-line symbols shall be spaced properly to facilitate viewing results on the one-line.
- 4. Falls City Utility will have multiple operating conditions, including, but not limited to, generation on/off, shutdown, bus-ties, start-up, emergency operation, etc. Consultant shall discuss facility operation with designated staff to determine the possible operating modes of the system. Each of the operating modes shall be documented and modeled in the software to determine the worst-case arc flash hazard and associated parameters for the electrical equipment.
- 5. All relay data shall be modeled based on the actual nameplate data including manufacturer, type, style, trip device, and actual settings. Generic substitutions or assumptions shall not be allowed unless data cannot be field verified. All assumptions shall be documented in the report.

- 6. All overcurrent relay types for the distribution system shall be modeled on the one-line diagram (and database) including phase and ground overcurrent, differential, residual, ground neutral, etc. to establish a complete and detailed system model where protective device data can be easily modified and updated by the facility and all data is available for a comprehensive protective device coordination study if required in the future.
- 7. Relay models shall depict the actual connection requirements.
- 8. Multi-function relays shall have all their overcurrent devices modeled in a single device and shall be able to accept multiple CT's.
- 9. All equipment modeling must have a corresponding one-line diagram symbol.
- 10. All system modeling shall conform to accepted modeling practices as outlined in IEEE-399 "Brown Book". Consultant may provide more advanced modeling techniques where compliance with the specification is maintained.

## IV. SHORT CIRCUIT STUDY

- A. A short circuit study shall be performed to verify all equipment duties. The calculations shall comply with ANSI C37.010, C37.13, C37.5, IEEE-141, and IEEE-399. The short circuit study shall verify the system electrical equipment is properly rated to withstand and interrupt the expected bolted and arcing faults in the system. Improperly rated and applied equipment may not protect personnel against arc flash hazards even if properly applied PPE is used. The software program must comply with the above standards in order to properly verify equipment.
- B. The equipment duty verification shall determine both the line side and load side fault current through each equipment and use the highest current to verify equipment ratings. Standard bus faults are not acceptable for protective devices in that they do not accurately model the current through the device and consequently they provide erroneous results. For solidly grounded systems, both three-phase and single-line-to-ground faults should be modeled. For other grounding configurations only a three-phase fault is required.
- Equipment duty results shall be graphically displayed on the electrical one-line as well as tabular report format.
- D. The results of the equipment duty verification tabular format report shall provide the following data:
  - 1. Equipment name and kV
  - 2. Manufacture, type, style, and ratings of the device
  - Actual line or load side currents through the device and percent over/under duty

- 4. Flag for the device showing VIOLATION or WARNING level for visual identification.
- A report of all problem areas shall be provided. A recommended action list shall be provided for all underrated equipment in each system.

## V. PROTECTIVE DEVICE COORDINATION (PDC) REVIEW

- A. PDC review shall be performed to determine if protection characteristics are sufficient to provide reliable power to the facility. The PDC review will also determine if the existing settings entered in the software will provide proper personnel protection in the arc flash portion of this study. At locations where only instantaneous breakers or fuses are used, this section may not apply.
- B. The PDC review shall consist of selecting several key areas in each system and plotting the time-current curves (TCC's) to verify proper selective operation of the protective devices. The review should also determine if the settings could be enhanced to provide increased personnel/equipment protection without sacrificing selective coordination. The consultant shall determine in conjunction with the (Utility Name) the areas to be reviewed.
- C. The consultant shall notify Falls City of any potential problems in the protective device settings that affect either selective operation and reliability or personnel protection before continuing with the study. Falls City may then opt to continue with the study using existing settings or to extend the contract for a complete PDC study to correct the settings before continuing with the arc flash study.
- D. As specified in the data collection and modeling sections, all PDC data shall be modeled on the one-line diagram and in the equipment database.
- E. TCC Specifics: The TCC's shall graphically illustrate on log-log paper that adequate time separation exists between series over current protective devices. The specific time-current characteristics of each protective device shall be plotted in such a manner that sufficient upstream devices will be clearly depicted on one sheet to prove selective coordination.
  - a. TCC's shall include a system one-line diagram and protective device coordination curves for each device in the selected area. The TCC shall be printed in color on 8 ½ x 11" paper – full size portrait mode, using a log-log scale. The one-line diagram shall be part of the TCC and include all protective devices, equipment names, and short circuit currents calculated from the main one-line. The purpose of this requirement is to provide all necessary information on one sheet, in a format easily readable and standard to the industry.
  - TCC's shall be developed for both phase and ground protective devices. One phase and one ground TCC should be developed for each substation. The

TCC should show the largest feeder protective device up through the switchgear/switchboard feeder breaker, transformer, unit substation primary fuse, and feeder breaker.

## VI. ARC FLASH STUDY

- A. A detailed arc flash study to determine potential arc flash incident energies, arc flash boundaries, shock hazard boundaries and proper personal protective equipment (PPE) for all energized electrical system equipment. The calculations shall comply with NFPA-70E 2004, and IEEE-1584. Bolted short circuit calculations used in the above standards shall comply with ANSI C37.010, C37.13, C37.5, IEEE-141, and IEEE-399. The purpose of this study is to determine arc flash hazards in conformance with NFPA-70E and the BPW's ongoing safety program, and to provide a comprehensive software model of the electrical distribution system, which provides arc flash calculations in compliance with NFPA 70E Article 130.1(A)(2) for all equipment. The software program used in this study shall comply with the above standards. No substitutions in calculation methods will be allowed.
- B. The arc flash study shall determine the following results for various modes of operation developed in Section 1- H. The results shall be provided in spreadsheet format for each mode and electrical system location to provide easy viewing and comparison. Worst-case arc flash energy levels shall be flagged, and the spreadsheet comparison table shall be capable of providing its output directly to high quality vinyl label printers. The spreadsheet results shall include:
  - a. Equipment name and voltage.
  - b. Upstream equipment device name and ANSI function, i.e., 51/50, etc.
  - c. Equipment type, i.e., switchgear, MCC, Panel, VFD, etc.
  - d. Equipment arc gap.
  - e. Bolted and estimated arcing fault current at the fault point (equipment) in symmetrical amperes. The estimated arcing current should be based on the arcing current equations used.
  - f. Trip time, opening time, and total clearing time (total Arc time) of the protective device.
  - g. Worst-case arc flash boundary for each bus/equipment in the model.
  - h. Worst-case arc flash hazard incident energy in cal/cm2 for each bus/equipment in the model.
  - i. Worst-case personal protective equipment (PPE) for each bus/equipment in the model.



- j. Working distances for up to five different distances showing items 7, 8, and 9 for each distance.
- k. Indicate "Danger/Hazardous" areas where incident energy is greater than 40 cal/cm2 and provide recommendations to reduced arc flash energy levels for these areas.
- Flag results where 85% arcing current provided worst-case results.
- C. Each mode of operation shall include a detailed write-up indicating areas where incident energy calculations and PPE requirements are higher than calculated in the normal operating mode.
- D. Consultant shall provide a detailed arc flash analysis report including as a minimum:
  - a. Introduction.
  - b. Methodology.
  - c. Information Sources.
  - d. Key Assumptions.
  - e. Arc Flash Energy and other considerations for various System Modes of Operation (maintenance mode, bus-tie, co-gen on/off, etc.).
  - f. Arc Energy at 100% and reduced currents.
  - g. Over current Protective Device Changes, Replacements or Setting Changes implemented in study to reduce arc flash hazard exposure of Data in Arc Flash Hazard Report Tables.
- E. NFPA 70E Information.
  - A. Shock Hazards with covers removed.
  - B. Shock Hazard Approach Boundaries.
  - C. Limited Approach Boundary.
  - D. Restricted Approach Boundary.
  - E. Prohibited Approach Boundary.
  - F. Arc Flash Hazard Boundaries.
- F. Results of Arc flash Hazard Analysis for all voltages including:
  - A. Working distances.
  - B. Energy Levels.



- C. PPE Requirements.
- D. Recommendations to reduce arc flash hazard energy and exposure.
- G. Arc Flash Hazard Report.
  - A. 5 Hard Copies.
  - B. 1 Electronic Copy in Adobe Acrobat format.
  - C. Electronic file for Power System Modeling Software as developed and utilized for this analysis.
  - D. Consultant shall provide an option to print labels for the (Utility Name) (see Project Options section below) or for the (Utility Name) to print labels for all equipment in the system from the project study file. Assume three (3) labels per equipment/bus in the estimate using 4" x 6" labels or one (1) 6" x 8" label per equipment bus. The labels shall be UV resistant vinyl labels (white with orange warning strip and black letters) conforming to ANSI-Z535.
- H. Software Requirements: The software shall provide complete integration of the one-line database, short circuit, PDC and Arc flash functions. Software using separate short circuits, PDC, TCC or arc flash programs is not allowed. Spreadsheet calculations are not allowed. The purpose of this section is to ensure that the arc flash hazard calculations comply with NFPA-70E and IEEE-1584, and that the calculations are programmed with necessary requirements to help eliminate possible errors in the arc flash calculations. The additional purpose is to establish a detailed software model for each of the (Utility Name) owned facilities, which will document the (Utility Name) compliance with the OSHA requirements and NFPA 70E mandates. These models will serve as an integral part of the BPW's ongoing safety program by providing arc flash calculations in compliance with NFPA-70E Article 130.1(A)(2).
  - A. Arc flash calculations shall be performed with enhanced IEEE-1584 equations, which eliminate voltage discontinuities and the non-conservative/average results of the standard equations. The purpose of this requirement is to ensure that the calculated incident energies are closer to actual test results ensuring a conservative calculation minimizing personnel risk.
  - B. The arc flash calculations including arc flash boundary, incident energy, PPE requirements, and working distance shall be displayed on the software one-line diagram and TCC simultaneously.
  - C. The arc flash calculations shall include four (4) calculation options to ensure that the software provides the flexibility required to meet any system configuration requirement that may be considered. Each

calculation option shall comply with the graphic and spreadsheet display requirements of this section. Each option is more specifically described below.

- The detailed option shall provide the let-through energy for each protective device in the system or on selected equipment. This is the energy on the load side of the protective device. The equipment shall be highlighted when the let-through energy exceeds a user defined threshold-clothing limit.
- 2. Worst-case including main protective device. This option shall provide the worst-case arc-hazard energy for the equipment based on the let-through energy of the equipment's main protective device. If the equipment is not equipped with a main device, the program must traverse back the entire system to determine the fastest series upstream protective device. The equipment shall be highlighted when the let-through energy exceeds a user defined threshold-clothing limit.
- 3. Worst-case excluding main protective device. This option shall provide the worst-case arc-hazard energy for the equipment based on the let-through energy of the fastest upstream series protective device in the system. The program shall traverse back the entire system to determine the fastest upstream protective device. The equipment shall be highlighted when the let-through energy exceeds a user defined threshold-clothing limit.
- 4. Worst-case excluding and including the main protective device. A combination of options 'b' and 'c' as stated above.

## VII. REPORTING AND ANALYSIS SUMMARY

Provide a detailed written report that includes the following:

- Executive Summary: The executive summary shall be brief, 1-2 pages maximum and cover at an executive level the findings of the study, recommendations, and requirements for maintaining NFPA-70E compliance.
- Scope of studies performed: The scope shall provide details of what actions were intended to be performed for each aspect of each study, including short circuit, protective device coordination, and arc flash.
- Description of each facility's system and explanation of bus and branch numbering system.
- Modes of operation studied: Each scenario/plant operating condition shall be thoroughly documented.



- 5. Detailed report and results of short circuit, coordination, and arc flash studies including:
  - Recommendations and additions to equipment ratings and/or PDC characteristics.
  - b. Recommendations to reduce arc flash hazards for equipment with incident energies over 40 cal/cm2.
- 6. Prioritized recommendations for all studies.

## VIII. QUALITY ASSURANCE

- A. The studies shall be in conformance with the NFPA and ANSI Standards, and IEEE recommended practices detailed in this section. No substitutions in study methods or software conformance will be allowed.
- B. The consultant is responsible for compliance with all performance specifications in this proposal. Any deviation from complete compliance must be noted on the performance specification submitted for review and approved before work begins.
- C. Consultant shall indicate compliance with The Board of Public Works insurance requirements as outlined in the attached insurance requirements document.



This AGREEMENT is between the City of Falls City, NE – Public Works Department ("Client") and Farris Engineering, Inc. ("Consultant") for Services to be provided by Consultant for Data Collection and Arc flash Study Analysis ("Project"), as described in the Consultant's Proposal(s) dated December 8, 2023, unless the Project is otherwise described in and/or included as an attachment to this Agreement.

- 1. Scope of Services. The scope of the Consultant's services is described in the Consultant's proposal unless Services are otherwise described and/or included as an attachment to this Agreement. The Consultant reserves the right to subcontract portions of the services described, subject to Client's approval of sub-contractor(s).
- 2. Acceptance. The Client agrees that acceptance of this Agreement requires the Consultant to execute the Services, and if Services commence by the Consultant prior to acceptance of this Agreement as an accommodation for Client at Client's request, both parties shall consider that commencement of Services constitutes formal acceptance of all terms and conditions of this Agreement. Any additional terms and conditions may not be added or changed unless written amendment to this Agreement is signed by both parties. In the event Client uses a purchase order, or any other Client supplied form to commence Services, that purchase order or other form assumes acceptance of this Agreement. Any additional or conflicting terms it contains are stricken.
- Standard of Care. Consultant will perform the Services listed in a manner consistent with that level of care and skill
  ordinarily exercised by members of the profession currently practicing under similar conditions in the same locale.
  Consultant makes no warranties or guarantees, express or implied, in relation to its Services.
- 4. Compensation and Terms of Payment. Client shall pay compensation for the Services performed at the fees delineated for all personnel and direct expenses under this Agreement, in the Proposal unless fees are otherwise stated and included in addition to this Agreement. Consultant will invoice Client monthly, and payment is due within 30 days of invoice date unless other payment terms have been agreed upon. Client shall notify Consultant in writing, within fifteen (15) days of the date of the invoice if Client objects to any portion of the charges on the invoice and shall promptly pay the undisputed portion. Chargeable time for Consultant's personnel is that portion their time devoted to providing services requested by Client. If Client fails to make payment in full to consultant within sixty (60) days after the date of the undisputed invoice, Consultant may, after giving seven (7) days' written notice to Client, suspend services under this Agreement until paid in full, including interest of 6% annum. Consultant shall have no liability to Client for delays or damages caused by such suspension of services. Client agrees to pay all costs of collection, including reasonable attorney's fees, incurred by consultant because of Client's failure to make payments in accordance with this Agreement, Unless noted otherwise, the fees included in the proposal for the subject project do not include sales, use, or similar taxes. If applicable to this agreement, those taxes will be added to the applicable invoices for the subject project. Consultant's income and similar taxes are not liable for payment by the Client, and these and similar taxes will be paid by the consultant without additional reimbursement by the Client.
- Change Orders. Client reserves the right to request changes to the scope of Services at any time. If Client so requests, Consultant will return to the Client a supplemental proposal of the change setting forth an adjustment to the Services and fees for the Change Order. Client must review and provide written acceptance of any supplemental proposals. If Client otherwise directs, authorizes, or permits Consultant to perform changes to its Scope of Services, the Consultant will be paid for this work according to the fees stated in the Consultant's current fee schedule.
- 6. Discovery of Unanticipated Pollutant and Hazardous Substance. Environmental investigations and reports including asbestos detection and abatement procedures are provided by others. Consultant shall have no responsibility for discovery, presence, handling, removal, or disposal of or exposure of persons to hazardous materials or toxic substances in any form. Client agrees that the discovery of unanticipated pollutants and/or hazardous substances may delay or alter the schedule of project. Consultant agrees to notify Client as soon as practically possible upon encountering such pollutants or substances. Client agrees that all remedial actions necessary are the responsibility of the Client and are not included in consultants' services. The client agrees to indemnify and hold harmless the Consultant of all damages arising from the discovery of hazardous materials.

- 7. Limitation of Liability. The Client and Consultant have agreed to the risks and rewards associated with this project. The total aggregate liability of the Consultant (and its employees) to client and third parties granted reliance is limited to its fee, for all injuries, damages, claims, losses, or expenses (including attorney and expert fees) arising out of consultant's services or this Agreement regardless of cause(s) or the theory of liability, including negligence, indemnity, or other recovery. This limitation shall not apply to the extent the damage is paid under Consultant's professional liability policy.
- Third Party Reliance. This Agreement and the Services provided are for the Consultant and Client's sole benefit and
  exclusive use with no third-party beneficiaries intended. Reliance upon the Services and any work product is limited to
  Client and is not intended for third parties.
- 9. Insurance. Consultant represents that it carries, and will continue to carry Professional Liability Insurance, as well as all other insurances required by local laws. Certificate of insurance will be provided upon request. Consultant shall furnish Client a certificate of insurance upon request showing amounts and types of insurance carried by Consultant, which certificate shall contain a commitment by the Insurance Company that during the time any work is being performed by Consultant under this Agreement it will give Client ten (10) days advance notice of cancellation or change in the insurance coverage shown on such certificates.
- Ownership of Documents. All documents including but not limited to drawings, specifications, reports, logs, data, notes, or calculations, prepared by the Consultant shall remain property of the Consultant. Concepts, systems, and ideas developed during performance of the Services shall also remain the sole property of the Consultant. Any unauthorized use of documents or ideas is subject to punishment under federal and local laws. Any authorization for use of Consultants documents or ideas must be approved in writing by the Consultant and does not permit use by any others than those specifically stated.
- 11. Opinions of Construction Cost, and Financial Considerations and Schedules Relating to Cost. In providing options of cost, financial analyses, economic feasibility projections, and schedules for the Project, the Consultant has no control over the cost of labor, materials, equipment, or services furnished by others, or over the Contractor(s) methods of determining prices, or over competitive bidding or market conditions. Consultant's opinions of probable Total Project Costs and Construction Costs provided for herein as appropriate are made on the basis of Consultant's experience and qualifications and represent Consultant's judgments as an experienced and qualified professional consultant familiar with the construction industry. Consultant makes no warranty that the Client's actual Total Project or Construction Costs, financial aspects, economic feasibility, or schedules will not vary from the Consultant's opinions, analyses, projections, or estimates. If Client wishes greater assurance as to any element of the Total Project or Construction Cost, feasibility, or schedule, Client will employ an independent cost estimator, contractor, or other appropriate advisor.
- 12. **Project Services Performance Schedule.** Consultant will make every possible effort to work within project schedules for the project. Project delays caused by an act or neglect of Client, a contractor employed by the Client, by delay Client has authorized in writing, or by other causes that the Client determines may justify delay. Consultant shall not be in default under this proposal for delays in performing the work. Consultant shall, within a reasonable time-period of being prevented from performing tasks, give written notice to the Client describing the circumstances preventing continued performance and efforts being made to resume performance of basic services and Consultant may be entitled to equitable adjustments in schedule of performance and compensation in the event delays occur.
- 13. Site Access and Safety. Client shall provide all necessary site related approvals, permits, and consents necessary to commence and complete the Services. Consultant will be responsible for the supervision and site safety measures for its own employees but shall not be responsible for the supervision or health and safety precautions for any other parties, including Client's personnel, the Consultant's sub-consultants, or construction contractors and his/her subcontractors.

Client shall provide this opinion to Consultant and the parties shall attempt to resolve the dispute within thirty (30) days through direct negotiation, after which Client may pursue its remedies at law.

- 16. Indemnity. The Consultant and its Client shall indemnify, and hold harmless the other, their agents, and any employees, from and against legal liability for claims, losses, damages, and expenses that were caused by either party negligent acts. Comparative fault principles shall be borne by each party in proportion to its own negligence.
- 17. **Termination**. Either party may terminate this Agreement or the Services for convenience upon thirty (30) days written notice to the other or for cause if either party fails substantially to perform through no fault of the other and does not commence and make a continuing effort to effect correction of such non-performance within seven (7) days of written notice. In such case, the Consultant shall be paid costs incurred, and fees earned, to the date written notice is received at the Consultant's office. In the event this Agreement is terminated by the Consultant, the Consultant will not be held responsible for any cost incurred by the Client after the date of termination.
- 18. Severability. If any of the provisions contained in this Agreement are held for any reason to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability will not affect any other provision, and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
- 19. Governing Law. This Agreement is to be governed by the laws of the State of Nebraska.

## Farris Engineering Reference Document: Why do I need an Arc Flash Study?

The purpose of an arc flash study is to identify potential electrical hazards and violations of safety regulations within your facility. The study calculates the amount of energy that could be released during an arc flash incident and evaluates the potential risks to workers.

An Arc Flash Assessment / Analysis is a study of the facility's power system to determine the incident energy available at specific electrical devices that employees would be exposed to while "interacting with" the electrical equipment at the facility. The output of the Assessment/ Analysis is a determination and labeling of the PPE required of the electrical devices, suitability of the devices for service as installed and if there are any miss-coordination issues involved as the system is currently installed.

A short circuit current available analysis and the clearing times of the overcurrent devices involved is required to determine the incident energy at the various points in the system.

OSHA 1910.132 requires that employers identify and protect their workers from workplace hazards. Every industrial / commercial power system includes inherent risks – specifically electrical shock and arc flash, anytime employees are "interacting with" electrical equipment while energized. Interacting with electrical equipment includes operation of fully enclosed switches and power circuit breakers as well as any exposure to energized equipment or circuit parts, including all energized testing or troubleshooting activities.

NFPA 70E – Standard for Electrical Safety in the Workplace, Section 110.1 – requires "The employer shall implement and document an overall electrical safety program that directs activity appropriate to the risk of electrical hazards. The electrical safety program shall be implemented as part of the employer's overall occupational health and safety management system, when one exists." Section specifically includes identifying and quantifying the risks of both shock and arc flash hazards before work begins.

NFPA 70E, Section 130.5 Arc Flash Analysis – requires an arc flash risk assessment shall be performed to determine the risk, safety related work practices required, the arc flash boundary, the incident energy at the working distance, and the PPE that people within the arc flash boundary shall use. This assessment shall be reviewed at intervals not to exceed 5 years.

NFPA 70E Section 130.5 (H) Labeling – requires all equipment "likely to require examination, adjustment, servicing, or maintenance while energized shall be field marked" ... with a label containing arc flash risk identification, severity of the risk, arc flash boundary and required PPE level among other things. This includes any energized testing or troubleshooting activity.

NFPA 70E, Section 110.3 (A) Host Employer Responsibilities – requires that host employers of contractors or outside service personnel are responsible for notifying the contractor of the hazards they may encounter in the performance of their work. This holds the host employer / facility owner responsible for identifying the hazards a contractor may encounter on the site. Therefore, using contract maintenance and electrical workers does not reduce the need for arc flash analysis.

It is impossible to know what level of arc flash hazard risk is inherent in your power system without assessment by knowledgeable technical resources. However, it is a true statement that every industrial / commercial electrical system has some level of inherent arc flash hazard. To protect the safety of your employees or contract employees working on or operating your electrical equipment an arc flash assessment must be completed and the equipment appropriately labeled.
