A meeting of the City Council of the City of Falls City, Nebraska, was held in said City on the 15th day of December 2025, at 6:00 o'clock P.M. Council met in regular session. Mayor Harkendorff called the meeting to order, and Clerk Nussbaum recorded the minutes of the meeting. On roll call the following Council persons were present: Ferguson, Fouraker, Kaster, K. Killingsworth, F. Killingsworth, Leyden, Ruiz. Absent: Buckminster. Notice of the meeting was given in advance thereof by posting in three public places, a designated method for giving notice as shown by the Certificate of Posting Notice attached to these minutes. Notice of this meeting was given to the Mayor and all persons of the Council and a copy of their acknowledgment of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings shown hereafter were taken while the convened meeting was open to the attendance of the public. Mayor Harkendorff publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

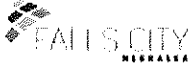

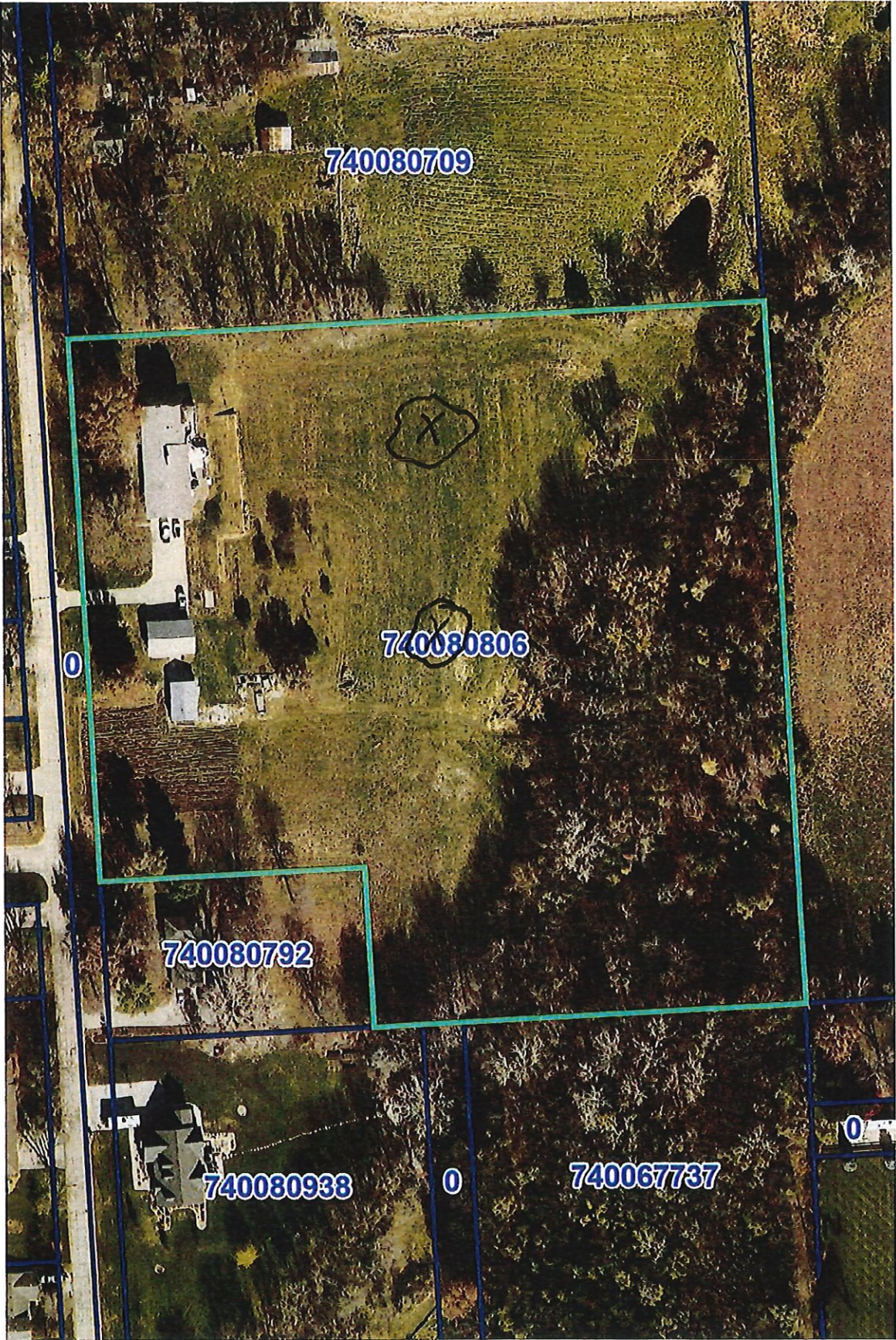

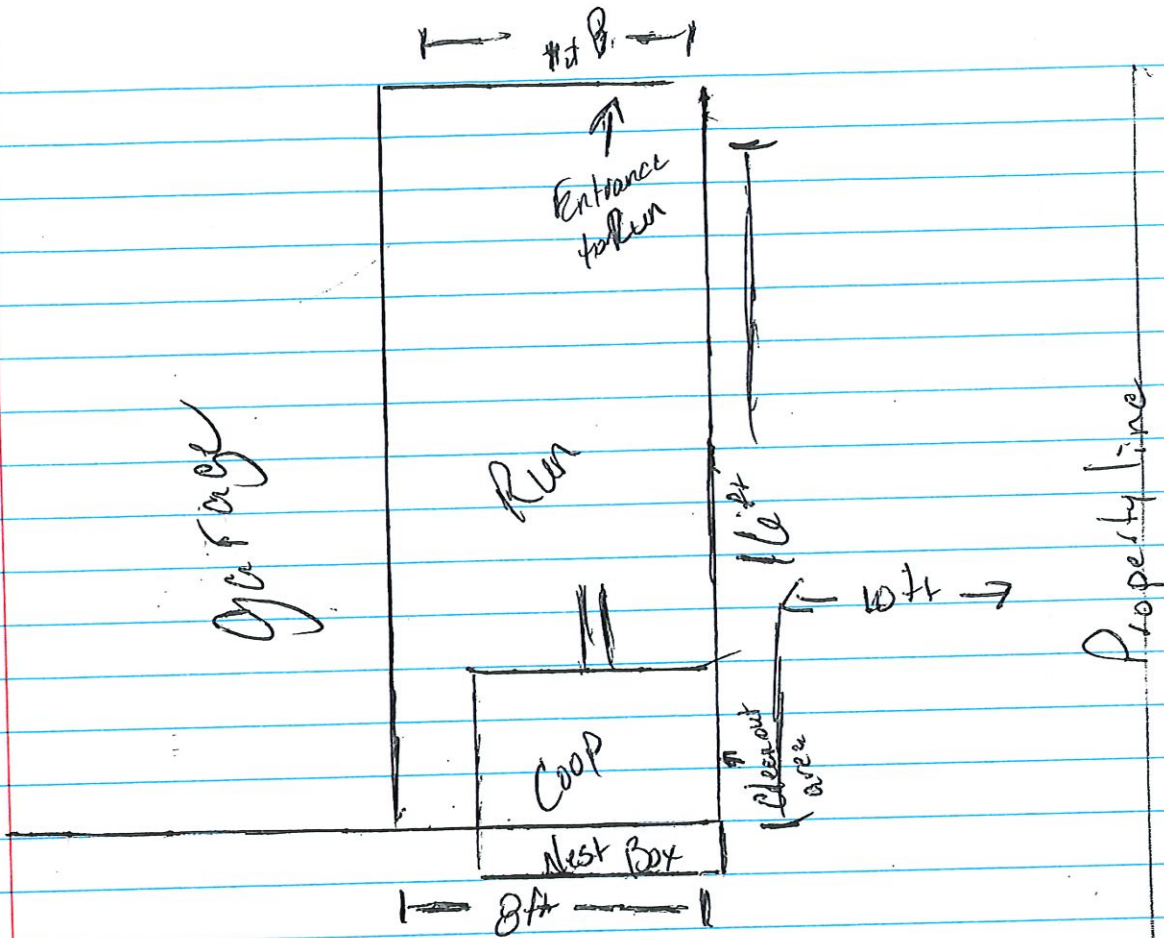

District #2 Regarding Infrastructure Fee**DATE** December 11, 2025

Richardson County Rural Water District #2 (RWD #2) submitted a letter dated December 9, 2025 requesting that the City waive the water infrastructure fee charged to the District until October 2026. The District states that during an in-person inquiry in September 2025, they were told the increase would apply only to the water rate and meter charge, with no infrastructure fee.

Staff recall the in-office inquiry referenced in the letter. During that visit, staff provided the RWD #2 representative with a printed copy of Ordinance 2025-103. Staff do not recall giving any verbal information, suggesting that the infrastructure fee would not apply.

The City of Falls City and RWD #2 are parties to long-standing wholesale water contracts that outline the rights and obligations of both entities. These contracts include provisions governing rate adjustments and specifically state that "any changes in the rates of payment by the Buyer to the Seller shall be in the same proportion as rate changes made by the City of Falls City with respect to charges made to its other water users". This clause is critical because it ensures that wholesale customers, including RWD #2, are treated equitably and that rate structures remain consistent across all classes of users. Without proportional application of rate changes, the City's cost-of-service model becomes imbalanced, shifting financial burdens onto other customers and undermining the sustainability of the water utility.

The 2025 Water Cost of Service Study identified wholesale classes: Rulo, Rural Water 2 WTP, and Rural Water 2 from 21st Street as subject to the full 6 percent increase beginning October 2025, of which 4 percent is the infrastructure fee. Rate classes "Rural Water 2 WTP" and "Rural Water 2 from 21st Street" apply specifically to RWD #2, while the "Rulo" rate class applies to the Village of Rulo. Attached is the relevant section of the study detailing those references. It should also be noted that the "Rural Water 2 from 21st Street" class encompasses both the West 21st Street metering point and the North Barada metering point used by RWD #2. All wholesale rate information including the infrastructure fee was publicly available as part of the City Council's review of the Water Cost of Service Study and adoption of Ordinance 2025-103.


The adopted water rates are established by Ordinance 2025-103, which is currently in effect and legally binding. Any change or waiver would require a formal amendment to the ordinance following the City's established legislative process. Waiving the infrastructure fee for RWD #2's wholesale accounts would reduce projected additional revenue from approximately \$14,323 to \$4,727, creating an estimated shortfall of \$9,596 for FY2026. It should be noted, the Village of Rulo is also a wholesale customer subject to the same ordinance-based rate structure.

RWD #2 independently sets its retail rates, and the City does not participate in or control the District's internal rate-setting decisions. Even if miscommunication may have occurred, the accurate and complete wholesale rate information was publicly available and provided to the District. Additionally, based on RWD #2's 2024 Audit Waiver Request, the District reported an anticipated cash-on-hand balance of \$377,840.00, which appears sufficient to absorb the increased cost of wholesale water until it is recovered through their own rate process.

Recommendation: The City should continue to apply the rates established under Ordinance 2025-103, including the infrastructure fee and encourage Rural Water District #2 to adjust its retail rates to reflect the full 6 percent wholesale increase, either at this time or during its next scheduled rate revision.

Should City Council decide a different direction or action, City Administration will fully accommodate and implement any direction or action that the City Council and the Board of Public Works determine to be the appropriate process moving forward.

Staff is requesting City Council approval of an engagement agreement with Baird Holm LLP to provide specialized legal services related to the Nebraska Power Review Board (NPRB) approval process and the development of complex development and service agreements associated with major energy infrastructure projects.

Legal support is required for the Energy Forward Transmission Project once it advances to the NPRB process. The cost for services related to the transmission project are grant funding eligible. 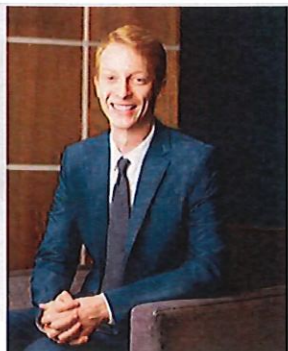

REGARDING CCCFF 2026 Grant Application Summary

DATE December 31, 2025

The purpose of this item is to inform the City Council of the City's intent to pursue funding through the 2026 Civic and Community Center Financing Fund (CCCFF) program in partnership with the Falls City Creative District. The Falls City Amphitheater Park is a proposed downtown public improvement intended to enhance community gathering space, support arts and cultural programming, and contribute to downtown economic vitality. The project is located adjacent to the Falls City Library and Arts Center and has been developed in partnership with the Falls City Creative District and other community stakeholders.

The City previously submitted an application for this project during the 2025 CCCFF grant cycle. While the project was not selected for funding, state reviewers cited strong project readiness, local support, and partnerships and encouraged resubmittal in a future funding cycle.

The deadline for submission of a full 2026 CCCFF application is February 15, 2026. Although the City Council is scheduled to meet on February 2, 2026, that meeting does not provide sufficient time to finalize and upload the complete application following Council action. As a result, advance authorization is requested to ensure eligibility for the 2026 funding cycle.

The 2026 CCCFF program requires a minimum cash match of \$375,000. To date, \$265,000 has been generated, consisting of:

- A \$200,000 funding commitment from the Stalder Foundation; and
- Donation of the project site property, which may be applied as eligible in-kind match.

The remaining cash match required to meet program thresholds will be fundraised by the Falls City Creative District.

This action does not commit any City cash funds. The requested authorization is limited to submission of the grant application. Acceptance of any award or future City financial participation would require separate City Council approval.

Requested Action: Approve the resolution authorizing submission of the Letter of Intent and the full 2026 CCCFF grant application for the Falls City Amphitheater Park.

Whereas, the 2026 CCCFF program requires a minimum cash match of \$375,000, of which \$265,000 has already been generated through a \$200,000 commitment from the Stalder Foundation and the donation of the project site property, which may be applied as eligible in-kind match; and

Whereas, the remaining cash match necessary to meet the CCCFF requirement shall be fundraised by the Falls City Creative District, and the City of Falls City is not committing any City cash funds toward the project as part of this authorization;

Therefore, be it resolved by the Mayor and City Council of the City of Falls City, NE, that:

1. The City Council hereby approves the Letter of Intent for the 2026 CCCFF application and authorizes its submission.
2. The City Council hereby authorizes the City Administrator or his designee to prepare and submit a full CCCFF grant application for the Falls City Amphitheater Park for the 2026 grant cycle prior to the February 15, 2026 deadline.
